2021 SCORP Stakeholder Engagement & Targeted Outreach

Background

To gather as much data as possible to inform the 2022-2026 Nevada SCORP, online surveys were utilized for three of the four discovery elements of data collection. The information requested was intended to provide valuable information about the interests, preferences, priorities, barriers and challenges of outdoor recreation from the public perspective. In addition, demographic information was collected for survey respondents. This information would be analyzed to help define the outcomes of this report, and to drive the funding opportunities for local governments over the next five years.

Research Methods

Data for the 2022-2026 SCORP were collected using three different survey instruments and an inventory spreadsheet. The initial public survey utilized a convenience sampling method and was offered to the public online in both Spanish and English. The second public survey (Part 2: How and Where We Recreate) was emailed to 1,479 respondents of the first survey who indicated willingness to provide additional information through additional surveys, interviews or focus groups. A third survey was targeted to land managers or any individual working within an agency, department or tribal community currently managing outdoor recreation facilities in Nevada. Results from each of these collection instruments were analyzed by TBC and are included in Appendices F and J.

Initial Public Survey

The 2021 initial public survey was developed by an internal SCORP Core Team made up of representatives from NDSP and NDOR. The survey was first beta tested by over 20 individuals that included SCORP Advisory Team members, agency staff and assorted "friends" of outdoor recreation who provided feedback regarding the content of the questions and the length of the survey. The survey was developed utilizing Survey Monkey and provided an on-line link (in both Spanish and English) easily circulated/distributed by a variety of organizations, agencies and key leaders across the state of Nevada, including the Governor in his weekly on-line newsletter to citizens of Nevada. The invitation to participate was included in five of the Governor's weekly newsletters circulated from February 26–March 26, 2021. The survey was also distributed throughout social media through the NDSP public information officer. Information about the survey and links were circulated on multiple Facebook pages, Instagram accounts, and via video interviews shown on local TV stations.

These outreach efforts were very successful, generating 6,086 responses to the public survey (compared to 317 SCORP survey responses in 2016). Of the responses that provided county-level data, population distribution of respondents totaled 82.23% from Nevada's three urban counties¹, 9.19% from three rural counties². 8.58% from eleven frontier counties³.

Public Survey Part 2: How and Where We Recreate

The final question on the initial public survey asked respondents if they would be willing to participate in an additional survey, interview or focus group. Of the 6,086 survey respondents, 1,479 respondents indicated they would like to provide additional information. It was to this group that an email was sent with a link to the Part 2 survey, "How and Where We Recreate".

As with the public survey, the internal SCORP Core Team created the survey that was then "beta" tested by agency staff. The Part 2 survey was distributed [date] and a follow-up reminder email was sent several weeks following the initial distribution of the link.

There were 721 responses to the Part 2 survey, a 48.75% response rate!

All survey respondents who provided an email address (1,479) received a draft of the SCORP for review and comment. We received feedback from 73 individuals.
