Small Business Impact Statement

Proposed Regulation: Various Changes to NAC Chapter 407

State Parks and Other Recreational Areas

Pursuant to NRS 233B.0608(1), the Nevada Division of State Parks must determine whether the proposed revisions and additions to NAC Chapter 407 are likely to: (a) impose a direct and significant economic burden on a small business; or (b) directly restrict the formation, operation or expansion of a small business.

Method

The Nevada Division of State Parks reviewed the proposed regulations specifically to identify any known or potential negative impacts on small businesses or park visitors.

Considerations included:

Potential competition created by regulation.

Potential negative impact on fee changes and permit processes.

Excessive burden imposed on small businesses to comply with regulation.

Special attention was given to the wedding industry and its use of State Parks. No information was found to indicate any negative impact on this particular small business use.

State Park fee changes and permit changes should not adversely impact the majority of park visitors, but will streamline the confusing and overly intricate fee system currently in place.

The reduction in overlapping use permits will allow visitors to easily obtain the park permit that best reflects the visitors' needs.

It was determined that State Park locations with proposed State operated cabin rentals were too distant or too specialized to place a direct and significant burden on small businesses.

Determination

No information was found to indicate that the proposed regulations are likely to: (a) impose a direct and significant economic burden on a small business; (b) or directly restrict the formation, operation or expansion of a small business; or (c) negatively impact park visitors.
