

**Reservation procedures and price:**

- Cabin rental rates are \$90 per night. This includes one vehicle. An additional vehicle is \$15/night and boats are \$5/night Maximum 2 vehicles. Annual permit holders may deduct the applicable entrance/camping/boating fee. Permit must be valid during occupancy
- All reservations must be made by a person 21 years of age or older. The individual making the reservation must occupy the unit.
- Payment is due in full with a credit card at the time the reservation is placed. Cancellations or date changes are permitted before 28 days prior to the reserved date and will be charged a \$20 fee.
- Reservations may be made up to 6 months in advance by date (Examples: A reservation starting July 10<sup>th</sup> could be made any time on or after January 10<sup>th</sup>. A reservation for August 30<sup>th</sup> can be made on or after March 1<sup>st</sup>)
- Guests who fail to arrive by 7am the morning after their reservation begins will have their reservation cancelled.
- Cabin 2 is designated as an ADA accessible cabin; this cabin will be held for individuals requiring additional accessibility unless no other cabins are available.
- Check-in time: After 3pm; Check-out time: no later than 11am (firm)
- To place your reservation, send a completed request form to [whsra@parks.nv.gov](mailto:whsra@parks.nv.gov) Please include all requested information. Put "cabin reservation" in the subject line.

**Rules:**

- Maximum occupancy for cabins:
  - Cabins 1 and 3 may have up to six occupants (adult or child combined including guests)
  - Cabin 2 may have up to four occupants (adult or child combined including guest)
- Maximum two vehicles per cabin.
- No tent/trailer/RV camping is allowed at the cabin sites. Campsites are available in the park campground.
- No smoking is allowed inside cabins or on the deck of the cabins
- In consideration of allergens and other guests, no pets or animals are permitted inside the cabins.
- If you require the use of a service animal, please let the park know so we can accommodate you.
- No gas or propane burners, heaters or appliances allowed in the cabins.
- Furniture must remain inside the cabin at all times.
- Cabin must remain clean and left clean upon checkout.
- The reserving party is responsible for full expense of any and all damages.
- Vehicles must remain on the prepared driving/parking surface.
- All other park rules and regulations apply.
- Violation of rules may result in reservation cancellation without refund and/or a fine.

**Additional Cabin Information and Amenities:****We provide:**

- Mattresses (cabin 1 and 3 have one queen bed, 1 twin bunk bed, one full size pull out sofa, and sleep 6. Cabin 2 has one queen bed and one full size pull out sofa and sleeps 4)
- Restroom with flushing toilet and sink (showers are available a short walk away in the campground)
- Microwave, mini fridge with freezer, table, chairs, outdoor grill and fire pit, air conditioning and heating, lights, power, and locking door
- Basic cleaning supplies

**You provide:**

- Sheets/blankets/pillows/bed roll.
- Charcoal and fire wood. (There is none for sale in the area.)
- Dining ware, food and beverage, coolers for additional food storage
- Garbage disposal is located by the Visitor Center
- Please remember winter access may be difficult
