The 5th Street Loop Trails were constructed as part of a 2016 RTP grant project - "Prison Hill Recreation Area - 5th Street Trailhead and Trails Project". Ground Disturbance:

This project proposes to construct a full-bench native-surface trail, approximately 24" - 28" wide and approximately 2 miles long.

Describe both current and past uses of the project area.

Project Area Use:

Prior to Carson City ownership, the Prison Hill Recreation Area was managed by the Bureau of Land Management (BLM). The property was conveyed from the BLM to Carson City in 2015 as part of a Federal Lands Bill. There is an existing social trail through this area which is filled with natural obstacles and has grades in excess of 20%. There are no other known uses.

Project Narrative

Project Need

Describe how this project fits with current community development plans.

Current Plans*:

Carson City has a Unified Pathways Master Plan (UPMP), approved by the Board of Supervisors in 2006, and revised in 2018. The UPMP is the result of extensive public input and it is the guide for trail development in our community. The UPMP places an emphasis on an interconnected system of trails, and this proposed trail is specifically identified in the UPMP.

Describe the project?s ability to enhance recreation options for an underserved area or population. ?Underserved? is defined as an area or population with inadequate services, facilities, and/or a lack of access to recreation opportunities.

Underserved Area or Population*:

The trailhead for this proposed trail is located directly across the street from Eagle Valley Middle School (EVMS), where according to the Nevada Department of Agriculture, 41.34% of the students are eligible for free school lunch, placing it in the "Mid-High Poverty" level. EVMS has a cross-country team that practices and holds events at the existing trailhead because it can be accessed by just a short walk from the school. This proposed new trail will provide additional opportunities for EVMS students to conduct their practices and host events, with a new added feature of an extended hill climb.

Project Quality

Describe project schedule(s) and contingency plans.

Schedule and Plans*:

1) The proposed trail alignment was completed in 2017.

3) If funded, this project could to out for bid in the spring of 2022.

4) Construction could begin in the summer or fall of 2022.

5) Any unanticipated delays could be resolved in 2022, and construction could be scheduled for completion in 2023.

Describe the confirmed partnerships for this project.

Partnerships*:

Our local non-profit trail advocacy organization, Muscle Powered, assisted with the field work to create the trail alignment, and they continue to support this project. Additionally, Visit Carson City (Carson City's Culture and Tourism Authority) recognizes that trails and outdoor recreation are a critical component of our community's economic vitality, and they also fully support this project.

Describe the nature and extent of public engagement with this project and what is being done to mitigate any concerns conveyed by the public.

Public Engagement*:

This trail is identified in the Carson City Unified Pathways Master Plan (UPMP), approved by the Board of Supervisors in 2006 and updated in 2018. The 2018 update incorporated single-track trail recommendations from the "Eagle Valley Trail Committee Community Trail Inventory, Review, Evaluation and User Needs Assessment Report" which was the result of a comprehensive multi-year grass roots effort that included an online survey and three public workshops.

Describe the implementation of best practices in each phase of the project (e.g., planning, budgeting, construction, etc.).

Project Phases*:

Planning: Extensive multi-year effort involving public participation to develop a single-track trail plan for Carson City. The result was an update to our Unified Pathways Master Plan, approved by our Board of Supervisors in 2018, which includes this proposed trail.

Trail Design: Alignment scoped and created by City staff aided by our local non-profit trail advocacy organization, Muscle Powered.

Budget: Grant match budgeted through Parks, Recreation & Open Space Dept. Maintenance is also budgeted.

Construction: The project will go to bid for a professional trail builder who will implement required BMP's throughout construction.

How does the project promote sustainability goals and principles (e.g., social, environmental, economic) in the design criteria?

Sustainability*:

Currently, social trails and their associated impacts are being created as people seek access to the Prison Hill North Loop Trail from the new 5th Street Trailhead and associated 5th Street Loop Trails. This more enjoyable, desirable, sustainably built and maintained trail will attract users and discourage creation of social trails. This was our experience with the 5th Street Trailhead and Trails Project where we created 1.6 miles of loop trails, then decommissioned about 5.5 miles of old roads and closed several single-track social trails. User numbers are up significantly since we opened the new trailhead, but the impacts in the adjacent area have been reduced as people are staying on the new trails and avoiding the old roads and social trails which are recovering to a more natural appearance.

Alignment with Nevada?s Recreation Goals

How will the project contribute to the maintenance and/or rehabilitation of existing outdoor infrastructure?

Existing Outdoor Infrastructure*:

This proposed trail will continue our efforts to make improvements on the north end of the Prison Hill Recreation Area that began with our 2016 RTP grant project: "Prison Hill Recreation Area - 5th Street Trailhead and Trails". That project, completed in 2020, essentially rehabilitated an area of about 60 acres where years of unregulated travel left numerous user-created roads and trails, many of them erosive and unattractive. This project will continue that effort by replacing some additional existing social trails and and discouraging creation of new social trails.

How will safety be implemented in the design, maintenance, and management of the project?

Safety*:

This proposed trail will be built to sustainable standards and the alignment has been designed to create 5% to 7% average grades to better manage speed and trail flow than the existing social trails it will replace which have poor sight lines and grades exceeding 20%. Trail conditions will be monitored annually, and volunteers from Muscle Powered will help with maintenance needs. Trailhead signage will display our "Share the Trail" messaging, including our slogan "Go Slow and Say Hello".

How does the project increase connectivity between trails, facilities, or other locations?

Connectivity*:

Our 2016 RTP grant project, "Prison Hill Recreation Area - 5th Street Trailhead and Trails", recently received the Coalition for Recreational Trails Annual Achievement Award for outstanding use of RTP funds in

the Community Linkage category. That project provided access to many miles of multi-use pathway throughout our community, including over 25 miles urban asphalt pathways and 14 miles of accessible aggregate trails throughout the Carson River area. Our currently proposed project will continue to enhance connectivity by providing linkages to many miles of single-track trails on the Prison Hill Recreation Area.

How does the project engage youth?

Youth Engagement*:

Eagle Valley Middle School (EVMS) is directly across the street from the trailhead for our proposed project. The school has a Cross-Country team which uses that trailhead to stage practices and host track meets. This proposed trail will provide EVMS students with additional opportunities.

Additionally, the Carson City Senators Cycling offers mountain bike instruction to youth of all ages and NICA competition for those who are interested. This trail will provide year-round access for youth organizations to ride when many other trails in our community may be unavailable due to weather conditions.

How will the project contribute (or otherwise complement) the development, maintenance, and/or management of new outdoor recreation facilities?

New Outdoor Recreation Facilities*:

This proposed trail will complement our nationally recognized 2016 RTP grant project: "Prison Hill Recreation Area - 5th Street Trailhead and Trails" by creating additional opportunities and destinations from this trailhead. The 5th Street Trailhead has become one of the most popular in Carson City, providing linkages to many miles of accessible multi-use pathways. Our proposed project will enhance connectivity by providing linkages to many miles of single-track trail on the Prison Hill Recreation Area.

How does the project contribute to the economic vitality of its community?

Economic Vitality*:

Carson City fully recognizes and embraces the value of outdoor recreation in supporting the economic health of our community. Visit Carson City (our Culture and Tourism Authority) fully supports this project, recognizing that trails draw tourists and events to our community, like the annual "Escape From Prison Hill Half-Marathon". This trail will provide additional opportunities for small events which could be staged at the new 5th Street trailhead.

How will the project contribute to the conservation and/or rehabilitation of water and habitat?

Water and Habitat*:

Development of a fun, attractive, and sustainable trail will discourage creation of social trails. People tend to remain on well designed and built trails, and defer from traveling randomly over a landscape. This is especially important in the area where this trail will be built because much of it crosses a burn scar from a July 2, 2021 fire. Discouraging cross-country travel will benefit rehabilitation efforts. We had huge success with abandonment, closure, and rehab of old roads and social trails following construction of the 5th Street Loop Trails where we created 1.6 miles of attractive trail and closed 5.5 miles of unsustainable roads and trails. Rehabilitation of this once highly impacted area is progressing well.

Applicant History

Summarize your organization?s grant management record. If your organization is new to grants, please summarize the organization?s project management record.

Grant Management Record*:

The Carson City Parks, Recreation & Open Space Department has managed three prior RTP grants, all completed within the allocated budget and time-frame. Our most recent project, the Prison Hill Recreation Area - 5th Street Trailhead and Trails project received a 2021 Coalition for Recreational Trails Annual Achievement Award for outstanding use of RTP funds in the Community Linkage category. Our staff has the expertise, knowledge, and experience to properly manage grants of any size.

Describe your organization?s capacity to maintain facilities for the next 25 years.

Maintain Program*:

The Open Space Division within the Parks, Recreation & Open Space Department, has a maintenance budget for trails and facilities on Open Space properties, like the property on which this trail will be located. Additionally, Carson City has a Memorandum of Understanding with the non-profit trail advocacy organization, Muscle Powered, to help us with long-term volunteer maintenance of single-track trails. Muscle Powered has a Crew Leader assigned specifically to Prison Hill.





For the past 20 years, Muscle Powered has advocated for a walkable and bikable Carson City at a grassroots levels. During that time, we have worked closely with Carson City to design and build non-motorized single-track trails in Carson City. We support efforts to develop a system of connected trails that provide both recreation opportunitues and nonmotorized transportion alternatives to the public.

The proposed Desert Peach Trail project will connect the award-winning 5th Street Trailhead and associated 5th Street Loop Trails with the popular North Loop on Prison Hill.
